Vietnam Retail Market - Trends and Trends in Retail Chain

Despite the Vietnamese government's target of 6.5% GDP growth in 2023, the country's GDP growth rate in the first quarter was only 3.32% due to the impact of the global economic slowdown. Vietnam's exports decreased by 8.33% year-on-year in the first quarter, and the manufacturing purchasing managers' index (PMI) for March reached 47.7 points, with the manufacturing and construction sectors showing a reverse growth, while the services sector was higher than a year earlier. grew by 6.79%, driving positive growth in overall GDP.

A closer look at the growth of the hospitality industry reveals that food and accommodation grew by 25.98% year-on-year, driven by an aggressive open-door policy to attract international tourists since March 2022, and continued growth in household disposable income.

followed by wholesale and retail at 8.09%, financial and insurance at 7.65%, and transportation and warehousing at 6.85%.

Vietnam selest 1/8 1957 tm/m (Natroph 9h) steel imports in May



In May 2023, Vietnam imported approximately 830,000 tons of steel, down 18.9% month-on-month, and approximately 300,000 tons of scrap, down 49.4% month-on-month. From January to May this year, Vietnam's steel imports decreased by 12.4% year-on-year, while scrap imports increased by 8.3% year-on-year.



Vietnam targets \$9 billion in seafood exports this year

According to the Vietnam Association of Seafood Exporters and Producers (VASEP), Vietnam will strive to reach \$9 billion in seafood exports this year. The target follows the industry's first-ever achievement of \$11 billion in exports in 2022. Speaking at VASEP's general meeting in Ho Chi Minh City on June 12, Chairwoman Nguyen Thi Thu Sac said the industry is facing challenges as consumer demand has dropped significantly due to worsening global inflation.
